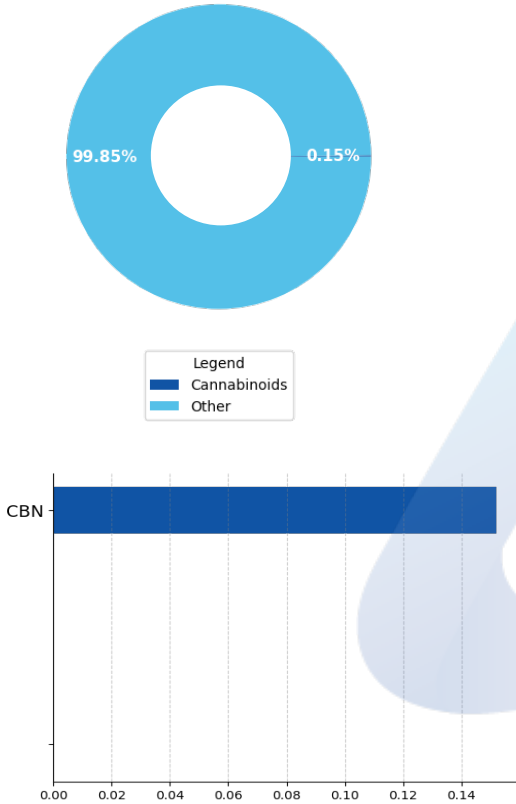



REMARKS

Passed visual inspection for particulates, mold, mildew, and other foreign substances. Two unknown analytes suspected to be R/S HHC can not be quantitated with method. Unknown Analyte 1 - Area Percentage = 21.177 % and Unknown Analyte 2 - Area Percentage = 46.184%. Unknown Analyte 3 suspected to be THC-O has an area percentage of 18.107 %.
